

## Terms and conditions

### HealthyFood: Strive for 5 between 1 and 31 October 2014

1. The promoter is Discovery Vitality.
2. The offer is open to all Discovery Vitality members, 18 years and older, who have an active Vitality membership and who have activated the Vitality HealthyFood benefit with Pick n Pay or Woolworths.
3. This competition is not open to Discovery employees and their direct family members, directors, affiliates, employees of the promoters, of Discovery Vitality or any other person who directly or indirectly controls or is controlled by Discovery Vitality.
4. The prizes are not transferrable or exchangeable and may not be redeemed for cash. The competition will run from 1 October 2014 until midnight on 31 October 2014.
5. Vitality members can win Pick n Pay or Woolworths vouchers if you buy 5 HealthyFood vegetables or fruit each week, during the month of October 2014.
6. To qualify for the competition, Discovery Vitality members need to purchase at least **five HealthyFood vegetable or fruit items each week** and **swipe the linked cards** listed below at the till before the cashier rings up the purchases. If you do not swipe the Vitality Pick n Pay HealthyFood card or DiscoveryCard at the Pick n Pay till, or the linked Woolworths card at the Woolworths till, before the sale is processed, you will not be entered into the competition. You cannot claim cash back or Vitality points for purchases afterwards.
  - **When you shop at Pick n Pay:**  
Swipe your Vitality Pick n Pay HealthyFood card at any Pick n Pay till before the cashier rings up your purchases to make sure you get your HealthyFood cash back. If you have a DiscoveryCard, swipe your DiscoveryCard twice – once before the cashier rings up your purchases, and again to pay.
  - **When you shop at Woolworths:**  
Swipe your linked Woolworths card at any Woolworths till before the cashier rings up your purchases to make sure you get your HealthyFood cash back. This includes the Woolworths WRewards card, MySchool, MyVillage or MyPlanet card.
7. Five Vitality members who meet all the competition requirements stand a chance to one of the main prizes:
  - Main prize – Pick n Pay and Woolworths vouchers to the value of R10 000.
  - 1 x Pick n Pay vouchers (to the value of R500)
  - 1 x Woolworths vouchers (to the value of R500)
  - 1 x Pick n Pay vouchers (to the value of R200)
  - 1 x Woolworths vouchers (to the value of R200)

8. Each HealthyFood item purchased at Pick n Pay and Woolworths will qualify for 20 Vitality points, up to maximum of 1 000 Vitality points for the month. We will deduct five Vitality points for every less desirable item you buy.
