Overview

From time to time, there are viruses or diseases that affect world health. Each outbreak is closely monitored by the World Health Organization (WHO) and depending on the severity and spread, can be declared as a global pandemic, or as in the case of monkeypox a Public Health Emergency of International concern.

The WHO Global Outbreak Benefit is available to all members during a declared outbreak period. The benefit provides cover for approved global disease outbreaks recognised by the World Health Organization (WHO) such as monkeypox. This benefit offers cover for the vaccine (where applicable and in line with national protocols), testing, diagnosis, out-of-hospital management and appropriate supportive treatment.

About some of the terms we use in this document

There may be some terms we refer to in the document that you may not be familiar with. Here are the meanings of these term.

TERMINOLOGY	DESCRIPTION
Day-to-day benefits	These are the available funds allocated to the Medical Savings Account (MSA) and Above Threshold Benefit (ATB), where applicable. Depending on the plan you choose, you may have cover for a defined set of day-to-day benefits. The level of day-to-day benefits depends on the plan you choose.
NAPPI code	This is a unique identifier for a given medicine, surgical or consumable product.

The following table contains the medicine on our list for supportive treatment of confirmed cases of monkeypox. You have full cover for medicine on our medicine list. If your medicine is not on our list, we cover it up to the lowest cost medicine of the same kind on our list.
