

Team Vitality non-Vitality member application form

A non-Vitality Team Vitality club member (also referred to as public Team Vitality members) refers to Team Vitality members without a Vitality Premium or Vitality Active membership are not eligible for the full Team Vitality benefits that are available.

Who may register membership?

Anyone 18 years or older can register with Team Vitality. You can join the Team Vitality movement at any time during the year. Your Team Vitality membership is valid from the dateof acceptance until 31 December of the year in which registration takes place.

Only during this time will you have access to Team Vitality benefits. You will have to renew yourmembership every year to continue having access to the benefits.

What you pay

Everyone who joins Team Vitality will pay an activation fee each year. The membership fee forthe year depends on your chosen sport:

- R1,675 a year for running
- R3,355 a year for cycling
- R5,030 a year for running and cycling
- ASA running licence R135

Regions eligible for running licences are Central Gauteng, Gauteng North, KwaZulu-Natal, Eastern Cape, Western Cape and the South Western Districts.

When you take up a Team Vitality membership and pay the membership fee, we will not beable to refund you once you have paid the membership. As a public Team Vitality member, you must email Team_Vitality_Documents@discovery.co.za to ask to have your membership cancelled.

Entry fees for races are not included in the membership fee and must be paid directly to event organisers.

Runners



Members living in Central Gauteng, Gauteng North, KwaZulu-Natal, Eastern Cape, Western Cape and the South Western Districts have access to a licence through Team Vitality. If you're from another region, you won't qualify for an ASA licence but can still join Team Vitality.

Cyclists

All cyclists will have to apply to CSA for a licence.

Getting started

Complete the application form in this document and pay the registration fee by EFT. Thereafter you can email your application form and proof of payment to Team_Vitality_Documents@discovery.co.za. Team_Vitality_Documents@discovery.co.za. Upon activation you will receive a welcome email from TeamVitality which will give you access to the voucher codes to redeem your Team Vitality kit.

Joining Team Vitality as a runner

If you live in Central Gauteng, Gauteng North, KwaZulu- Natal, Eastern Cape, Western Cape and the South Western Districts and are currently a member of a running club and want an Athletics South Africa (ASA) licence, you have to resign from your current club and send us your clearance letter.

Here's how to apply for a running licence:

Register on <u>ASA website</u> in order for Team Vitality to accept you as a member and verify your license details for **Gauteng North**, **KwaZulu Natal**, **South West District**, **western Province and Eastern Province**.

- 1. Purchase your ASA running licence for R135 when you sign up for <u>Team Vitality</u>.
- 2. Download the ASA application form.
- 3. Complete the form and send it to ASAformteamvitality@discovery.co.za.

Central Gauteng:

- 1. Register as a new or existing runner on the Central Gauteng Athletics (CGA) website.
- 2. Sign the form electronically or manually.
- 3. Forward the following documents to ASAformteamvitality@discovery.co.za:
 - o The completed and signed form from the CGA portal
 - Your proof of payment.

Team Vitality will allocate a licence number to you, the applicant, on the CGA admin portal.



Please note if you are a new running member and have bought a licence, or you are renewing it, you will need to collect your licence from the venues mentioned above in the 'Getting started' section.

If you are renewing your Team Vitality benefit and have bought a running licence, we aim to give you the same licence number as the previous year; however, this is not always possible.

If you live in another region or you already belong to a running club, you can join Team Vitality as a social member without the running licence.

If you are a new member or a member renewing your membership for the second year, you will receive a welcome mailer once you have joined. This mailer will include a wiCode which you can use to collect your running kit from Sportsmans Warehouse stores in Canal Walk, Moffet Retail Park, Eden Meander Lifestyle Centre, Rondebosch, Centurion, Fourways, Sandton or Gateway. Alternatively, you can opt to have your kit delivered for an additional fee of R50.

The region-of-residence rule (Team Vitality Running)

- An athlete will only represent the ASA province where they live.
- Except for a national-level athlete, a runner will only be a member of a club if the athlete and the club are in the same ASA province.
- No athlete may relocate from one province to another without being in
 possession of a written clearance certificate from their former province entitling
 them to compete in the new province. Failure to get such a clearance certificate
 will make theathlete ineligible to compete in the new province.

Entering races

Once you have selected the race you want to participate in, you will need to enter through the event website (not the Team Vitality website) and pay the race entry fee directly to the raceorganisers.

- Members will receive a voucher code in their welcome mailers to collect their TeamVitality running or cycling kit (or both if they signed up for both running and cyclingmemberships). Members are responsible for ordering the correct running and/or cycling shirt size by using the sizing chart we have provided instore.
- Team Vitality runners and cyclists from all regions and runners from licensed regions (Central Gauteng, Gauteng North, KwaZulu-Natal, Eastern Cape, WesternCape and the South Western Districts) must wear their race kit at all events.
- Please note that all imagery (photographs and videos) taken at Team Vitality
 events (including races, hospitality events, training rides or runs) may be used by
 Discovery Vitality for promotional and marketing purposes using print and
 online platforms. Bysigning this form, you allow us to do so.
- Discovery Vitality and Discovery Athletic Club NPO will not be responsible for any loss,damage, injury or death that you, your beneficiaries or any third parties may suffer byengaging in the Team Vitality programme.
